#### PROJECT BACKGROUND

#### 1. Background:

- (i) Uttarakhand Civil Aviation Development Authority (the "Authority" or "UCADA") is the owner of a Helidrome at Sahastradhara, near Deheradun, comprising a Helicopter Landing Area, Parking Area, Passenger Lounge, Two Hangars (Old Hangar and New Hangar), Guest House, Office Building and VIP Lounge ("Premises")
- (ii) With the aim of boosting helicopter operations at the Premises and promoting the Premises as an MRO hub for helicopters, UCADA is considering developing the Helicopter Landing Area, Helicopter Parking Area, Passenger Lounge and the New Hangar and open spaces pertaining to these facilities ("Project Site") on PPP basis. Summary of proposed Project Scope is provided below

### 2. Proposed Project Scope:

- (i) The Concessionaire may undertake the following upgradations at the Project Site
  - (a) Expansion of the existing Helicopter Landing Area (FATO, TLOF and Safety Area) and Helicopter Parking Area (Two Aprons) without disturbing existing permanent structures and to the extent permissible under Applicable Law
  - (b) Conversion of one Hangar into an MRO Facility
  - (c) Renovation of the existing Passenger Lounge
  - (d) Renovation of the existing Guest House
- (ii) The Concessionaire shall have the following rights and obligations during the Concession Period
  - (a) The Concessionaire may operate the MRO Facility in the New Hangar on its own or sub-lease/sub-license it on a commercial basis
  - (b) The Concessionaire may collect Helicopter Landing Fees and Helicopter Parking Fees subject to upper limits which would be specified by UCADA.
  - (c) The Concessionaire may operate the Guest House and collect room rentals from guests on a commercial basis
  - (d) The Concessionaire would be required to maintain all the Project Facilities and provide all services at the Project Site as per Applicable Law, Safety Standards and Industry Best Practices
- (iii) The proposed Concession Period for the Project shall be 10 year
